On behalf of all participants I want to thank Nathalie Urban, General Manager of the hotel. She and her collaborators welcomed us and made us feel at home. A special mention to Chef de Cuisine, Rubén Sesma for the delicious menu and coffee services during the meetings. Also, a special thanks to Braulio Arsuaga, the owner of this wonderful property.

The new regional structure based on the IHG Five Priorities (included in our previous MyNews) is already moving forward with IHG partners. The following bullet points resulted from working sessions of our meeting:

- Crowne Plaza rate must be in accordance to the market segment it is being targeted and different from Holiday Inn.
- Cost with IHG Voice to be reconsidered. This point will be followed up with IHG to get better conditions for hotels.
- Priority Club Rewards to IHG Rewards Club transition is being monitoring through Yelitza Guerrero, Manager of Loyalty Programs. She continues working with regional hotels through virtual sessions explaining the process.
- HeartBeat Survey still too long and difficult to gather emails.
- At present 80% of hotels are in failure on Fire & Life

- All hotels are aligned with IHG Internet Standard; nevertheless we will request a regional waiver to charge Premium Internet Service attending our guests requirements for a wide band range.

For the first time in Mexico we also held the Owners Summit. Our moderators were Mike Hembree and Buggsi Patel. They did an excellent job encouraging owners to work in groups and find out their most significant barriers and boosts, followed by an open discussion with IHG, and finishing with a Q&A Panel.
