

Text Messaging Communications Terms of Service

EFFECTIVE DATE: June 1, 2016

The IHG Owners Association (the "Association" or "We" or "Us") is committed to our members' privacy and security when using our Text Messaging Communications. We want you to understand how we collect, use and share user information and have created the below Terms of Service to serve as a guide.

The Text Messaging Communications is provided by the TXImpact through the IHG Owners Association. We intend to use this program for text messaging surveys, notices, promotions, etc. By signing up for this program, you agree to the following terms and conditions.

Opting In

The primary way to opt in to our Text Messaging Communications is to complete the web signup form. When you opt-in to the program, we will send you a text message to confirm your signup. You will receive no more than eight (8) text messages per calendar month.

Opting Out

You can cancel the Text Messaging Communications at any time. Just text "STOP". After you send the text message "STOP" to us, we will send you a text message to confirm that you have been unsubscribed. After this, you will no longer receive text messages from us. If you want to join our Text Messaging Communications again, just sign up using the web form as you did the first time, and we will restart the program.

Privacy Policy

We respect your privacy. We will only use the information you provide to transmit your text message. Nonetheless, we reserve the right at all times to disclose any information as necessary to satisfy any law, regulation or governmental request, to avoid liability, or to protect our rights or property. When you complete forms online or otherwise provide us information in connection with the Text Messaging Communications, you agree to provide accurate, complete and true information. You agree not to use a false or misleading name or a name that you are not authorized to use. If we, in our sole discretion, believe that any such information is untrue, inaccurate, or incomplete, we may refuse you access to the program and pursue any appropriate legal remedies.

We also send and receive Text Messaging to other international carriers.

Charges of Service

Subject to the terms and conditions of your mobile carrier, you may receive text messages sent to your mobile phone. The IHG Owners Association does not have a separate charge for our Text Messaging Communications; however, message and data rates may apply from your mobile carrier. If you have any questions about your text plan or data plan, it is best to contact your wireless provider.
