Advocacy and Representation

The Association's formal advice and counsel to IHG is performed through committees of owner volunteers, called Working Groups. Recent accomplishments include significant reductions of the loyalty assessment rate and the IHG Ignite fee, as well as numerous cost savings on brand standards. **Watch our video**.

Colleague Retention Programs

- One Allocation of 25 Free Nights is provided for each member hotel. One additional Free Nights Allocation per member hotel may also be purchased. All individuals with Free Nights Allocations also receive an upgrade to IHG One Rewards Platinum Elite status.
- Professional development opportunities through our Emerging Leaders Network (ELN).
 - The Association's ELN is designed to educate and support owners, operators and individuals on their teams who wish to advance their hospitality careers, especially within the Association itself. This forum offers networking and training opportunities to provide ELN members a unique opportunity to collaborate directly with IHG and to help drive owners' returns across the estate. ELN is focused on three areas: Building relationships, The Future of the Industry, and Personal Growth and Development.



Peer Connections

- We offer dedicated in-person networking opportunities to engage with other members and foster meaningful, business-building connections.
 - Across EMEAA, the Association hosts Regional Owner Meetings twice a year which are open for all members to attend. The meetings are attended by a Working Group Manager from the Association, along with the IHG leadership and specialists relevant to the agenda topics. At the meeting, members have the opportunity to attend a franchiseeonly session to network with other owners and operators and raise points for later discussion with IHG. This is followed by a joint session with IHG, where we drive advocacy for owners, hear updates across topics such as Commercial, People, Sustainability, and Technology, as well as any owner-led topics raised in advance.
